The minutes of the April meeting were approved.

The banking resolution was approved.

President McFarlin said she has worked to carry on efforts initiated by her predecessors. She has worked to keep the alliance strong between ASNE and APME. The groups are cooperating on an extensive FOI effort. She reported that a professional development project was under way to address the problem of insufficient commitment to training in the newspaper industry. This project is a collaborative effort between a variety of journalism organizations. McFarlin reported that the Campfire project was up and running on the ASNE Web site. The goal of the project is to create dialogue between ASNE members and make membership more appealing and useful for editors. Also, McFarlin outlined an effort by a coalition of journalism groups to analyze the economics of quality journalism. This effort will likely lead to a convention segment.

Scott Bosley, ASNE **Executive Director**, reported that the McCormick Tribune Foundation approved a grant for a Readership Training program, slated to start in January 2003.

**Vice President** Bhatia referred attendees to the list of his committee chairs for 2003-04. He noted that the Fall board meeting will be in late September in Portland, Ore., at the 5<sup>th</sup> Avenue Suites Hotel.

Karla Garrett Harshaw, reporting as **secretary**, noted that all the membership applications were routine and recommended that the board approve all applicants. The following Secretary's report was approved and the membership applications accepted:

Since the board met in April, there have been four deaths and 27 resignations and ineligibilities. No one is being dropped for nonpayment of 2002 dues at this time. There are 13 members to be transferred to the retired rolls. The board will consider five applications for membership. Assuming all are elected and the transfers approved, membership will stand at 810 dues paying; 606 active, 16 distinguished service and 188 retired. This compares to 827 at the same time last year.

In the **treasurer**'s report, Mr. Rodriguez noted that ASNE ended the year with a shortfall of \$40,804. He said that a \$30,000 unbudgeted reimbursement from the McCormick Tribune Foundation for credibility projects kept the loss from being even worse.

Scott Bosley noted that the Knight Foundation has given ASNE indication that they plan to fund the High School Project for another three years.

The treasurer's report was approved. The full treasurer's report is included with the 2002-03 budget on the next page.

Greg Moore raised an issue of journalists being beaten in Venezuela and asked that the board pass a resolution protesting these acts. The board decided to hold off on a resolution until finding out more facts related to this issue.

The board went into **executive session** to discuss the finances of ASNE and the findings of the budget subcommittee.

During the executive session, the board voted to charge 2003 dues as follows:

The board also agreed to survey members on their preference for shorter conventions and whether they would like conventions out of Washington every other year.

The committee chairs joined the board at 10:45 a.m.

Greg Moore gave the report of the **Diversity** Committee. He said the committee has focused a great deal on retention. A guide to help editors retain minority journalists is expected to be available at the April convention.

Bobbi Bowman, ASNE **Diversity Director**, reminded the board that next year was the first benchmark year since new goals were established in 2000. She reviewed current figures and indicated the benchmarks would not be reached. She said that the job fair rotation was under way and for the first time a job fair will be held at the National Press Club in February.

Edward Seaton reported on behalf of the **ASNE Foundation**. He noted that corporate contributions have decreased while individual member contributions have remained steady. He told the board that the Knight Foundation, while still funding various other Foundation projects, has discontinued their support of our diversity efforts. However, Knight has agreed to let the Foundation apply \$125,000 from the Institute for Journalism Excellence to the current year's diversity efforts. The Foundation board asked McFarlin, Bhatia and the Diversity Committee to review the Diversity program to see if any new initiatives could be started in order to entice funding from Knight and other organizations again.

McFarlin said that a decision had been reached to hold a Diversity Summit in early 2003 to brainstorm new approaches to diversity.

McFarlin informed the board that Bob Rivard could not be at the meeting, however, as chair of the **International Committee** his report was in the board books. She also noted that a key mission of the committee this year was the trip to Cuba following the board meeting.

Marty Kaiser gave the report of the **Readership Issues** Committee. He said that the committee has been focused on shaping the 24 training seminars that are being funded by the McCormick Tribune Foundation. The pilot program, sponsored by Gannett, will be held in White Plains, N.Y., November 19-20. The seminars are designed to help newspapers implement findings of the Readership Initiative.

Doug Clifton, chair of the **Freedom of Information** Committee, was not able to attend the board meeting. A copy of his report was put in all the board books. The committee has been very active in responding to FOI challenges and, with APME, has put together a series of advertisements for newspapers to run that underscore the importance of open records. NAA has agreed to distribute the ads.

Kevin Goldberg and Dick Schmidt, as **Legal Counsel**, updated the board on issues facing ASNE.

Bob Steele and Bill Mitchell of The Poynter Institute, in collaboration with Joann Byrd, chair of the **Ethics and Values Committee**, gave a presentation to the board on the interactive ethical decision making model that would soon be available to members on the Poynter Institute Web site and through a link on the ASNE site. The project was jointly funded by Poynter and ASNE Foundation.

Judy Pace Christie gave the report of the **High School Journalism** Committee. She said that the High School Project has really taken off over the last year. She noted that this year HSP has 33 new daily newspaper partnerships versus a goal of 20. These programs are formatted to either start a newspaper at a local high school or to substantially improve an existing newspaper. She reported that High School Journalism Institutes were being held at five colleges around the country during the summer months.

Diana Mitsu Klos, **Senior Project Director**, reported that the high school Web site was getting over one million hits a month and that material on the site is updated daily. She also noted that an adjunct site has been developed to host high school newspapers. There is a nominal signup fee and more than 100 schools are currently online.

Allen Parsons reported on behalf of the **Small Newspapers** Committee. He told the board that the committee had launched a project in conjunction with Campfire to send out an e-mail message every day with educational tips to editors across the country. Response has been very positive.

Janet Weaver gave the report of the **Multimedia** Committee. She said that the major undertaking of the committee was the Campfire project. Campfire's main goal is to tie the ASNE membership together more closely with more frequent communications. Committee information is posted on the Web site throughout the year. Jody Calendar was hired as a consultant for six months to help get the project up and running.

Gerald Boyd gave the report of the **Leadership** Committee. He said the committee is focusing on producing online seminars using leaders in the newspaper industry to talk about practical leadership experiences and challenges facing middle-level managers.

Frank Denton reported on behalf of the **Craft Development** Committee. He told the board that the committee is working on a book aimed at newsroom training and development. Denton also said that the committee would hold a meeting November 9-11 to develop a model for newsroom organization. Sherri Immediato from the Society of Organizational Learning will facilitate discussion at the meeting.

Rena Pederson gave the report for the **Convention Program** Committee. She said this year's convention theme was "Passion for Journalism". The convention will be April 8-11 in New Orleans. Receptions are being planned at the New Orleans Museum of Art and the D-Day Museum. She noted the convention schedule was still being developed, however, some key speakers including Kofi Annan, Colombian President Uribe, President Bush and former President Carter have been invited.

Karla Garrett Harshaw reported on behalf of the **Membership** Committee. She said that ASNE membership was at 810, compared to 827 a year ago. She asked board members to volunteer to contact members who have not paid dues to ask them to reconsider their membership. She also said a list would be created of non-members and a solicitation would be done to try and get those people to join. She noted that letters will be sent to key members at newspapers over 50,000 circulation encouraging them to add a member. The add-a-member special particulars are half-price dues for 2003, no initiation fee, and half-price member registration for the New Orleans convention.

Jennie Buckner gave the report for the **Education for Journalism** Committee. She said that the committee was focusing on marketing newspaper careers to college students, and would produce a book comprised of essays from journalists who will tell their own compelling stories about why they chose their careers and remain committed to what they do.

Charlotte Hall and Susan Bischoff reported on behalf of the **American Editor** Committee. Hall said the magazine's goal was to reflect the interests of the members, provide information and tips, and to showcase the work of the officers and the committees. She also said that the number of issues was cut from nine to six each year, and that color was added to all issues.

Rich Oppel gave the report of the **ASNE Awards** Board. He noted that the Awards Board will meet February 20-22 in St. Petersburg, Fla. The rotating writing category this year will be "Passion for Journalism", including news and commentary writing on journalism issues and experiences.

Rick Rodriguez, reporting as chair of the **Nominations** Committee, said that the next meeting to select a slate of candidates for the board of directors election will be on January 18 at The Poynter Institute in St. Petersburg.

The board resumed the executive session from the morning and Mr. Zeeck was elected to the ladder as treasurer-designate.

The meeting was adjourned.
