NCBA Condemns Extremist Attacks on Family-Owned Cattle Operation

National Cattlemen's Beef Association several other pieces of farm (NCBA) President Bill Donald said the alleged animal rights extremist attacks on Harris Ranch, located in Coalinga, Calif., is an example of extremists showing a disregard for property and lives. While law enforcement has not

confirmed who was responsible for the attacks, the North American Animal Liberation Press Office, publicly released information on Jan. 9, 2012, that included correspondence

from the group reportedly claiming responsibility.

"This is not only an attack on a familyowned and operated business; this is a domestic terrorist attack on our nation's providers of food and fiber," said Donald. "This extremist behavior goes above mere activism and the freedom of speech. These criminals are threatening lives and causing substantial economic harm."

The attack took place before dawn on Sun., Jan 9, 2012. Fourteen tractor trailers were engulfed in flames and

equipment were also damaged. No people or animals were reported hurt during the attack. Donald said those responsible for this attack are not at all concerned about the safety of livestock.

federal investigators and looks forward to seeing those guilty of this "heinous" crime prosecuted to the fullest extent of the law.

"These extreme attacks are nothing more than bad people doing bad things and they must be prosecuted to

He said NCBA strongly condemns any and all attacks against farming and ranching operations.

"Anyone concerned about the welfare of animals would not orchestrate attacks on individuals who are experts at caring for these creatures," said Donald. "Ranchers are undoubtedly the very best caretakers of livestock. Cattlemen and women implement the highest animal handling and food safety standards designed by veterinarians, animal behavioral experts and researchers."

Reports indicate that law enforcement will likely hold a press conference next week. Donald said he in encouraged by the swift action of California and

S. 1528 - Farm Dust Regulation Prevention Act

To establish a temporary prohibition against revising any national ambient air quality standard applicable to coarse particulate matter (dust), to limit Federal regulation of nuisance dust in areas in which such dust is regulated under State, tribal, or local law. The House version, H.R. 1633, passed on Thurs., Dec. 8, 2011. NCBA urges a **YES** vote S. 1528. Key Sponsor: Sen. Mike Johanns (R-Neb.)

S. 1061 / H.R. 1996 - Government Litigation Savings Act

Will amend the Equal Access to Justice Act (EAJA) to prohibit organizations with a net worth exceeding \$7 million from filing for EAJA funds; require EAJA filers to show a "direct and personal monetary interest" in the action to be eligible for payments; and cap the attorney fees. NCBA urges a **YES** vote on S. 1061 / H.R. 1996.

H.R. 3097 - The Renewable Fuel Standard Flexibility Act

To partially waive the renewable fuel standard when corn inventories are low.

NCBA urges a **YES** vote on the Renewable Fuels Flexibility Act.

Key Sponsors: Reps. Bob Goodlatte (R-Va.) and Jim Costa (D-Calif.)

H.R. 2414 - Farmers' Freedom Act of 2011

Exempts certain farm vehicles from certain federal requirements (for a commercial driver's license, drug testing, medical certificates and hours of service). Prohibits federal transportation funding to a state from being terminated, limited, or otherwise interfered with as a result of the state's exempting a covered farm vehicle from any state requirements governing the operation of that vehicle.

Key Sponsor: Rep. James Lankford (R-Okla.). NCBA urges a YES vote on H.R. 2414.

Double Deck Trailer Ban in Highway Safety Bill

Unfortunately, the U.S. Senate Committee on Commerce, Science and Transportation recently included the double deck trailer ban in S. 1950, the Commercial Motor Vehicle Enhancement Act of 2011. Section 905 of S. 1950 prohibits the transportation of all horses in double deck trailers, not just those bound for slaughter. This measure is currently waiting for further consideration on the Senate floor. The U.S. House Committee on Transportation and Infrastructure will likely mark up its version of

the Highway Bill in early February.

You may be curious as to why Congress is trying to expand this provision. This issue has been a strong interest of Senator Kirk (R-III.). While Senator Kirk was serving in the U.S. House of Representatives, he stated he introduced this legislation after an accident in Wadsworth, Illinois in October, 2007 involving the overturning of a double deck trailer carrying 59 Belgian draft horses. According to accident reports the driver ran a red light causing the accident. Several other accidents cited in background information supporting the ban were caused by driver error. Unfortunate accidents such as this remind those transporting livestock that continued education on transportation safety is vital. The welfare of the livestock we are transporting is our top priority and we must communicate this fact and not allow special interest groups to destroy our industries.

The U.S. Department of Agriculture currently regulates the transport of horses to slaughter and recently strengthened those regulations, but there are currently no other federal regulations on horse transportation. Passage of this provision would possibly lead to further restrictions on livestock transportation.

Rodeo stock contractors stand to suffer adverse effects if a ban on transporting on in double deck trailers is imposed. The rodeo industry actively opposes the ban with the following facts:

• While transporting horses and all livestock, the main goal should always be the safety of the trailer (i.e. headroom, road

worthiness, etc.). As with any form of transportation, accidents may happen and the focus of any potential legislation should be on safe transport, rather than the banning one specialized form of transportation.

- Stock contractors transport rodeo horses in double deck trailers which are specially ordered or specially modified in order to safely transport horses. These modifications may include changes made to ramps and doorways to safely accommodate horses.
- Rodeo horses must be fit and able to perform when they arrive at their destination. Thousands of horses are successfully hauled each year in specially modified double deck trucks.
- Many stock contractors have one level created with a higher clearance (up to 84 inches). The level with the lower floor to ceiling clearance is used to haul timed event cattle or bulls.
- The average height of a horse is approximately 60 inches. Floor to ceiling clearance in most double level trailers used to haul bucking horses range from 71 to 75 inches. This leaves from 11 to 15 inches of headroom for the average horse in these modified trailers, more than adequate.
- Taller rodeo horses are transported in the single level areas at the front and back of the modified trailers which may have up to 9 feet of floor to ceiling clearance.
- The majority of bucking horses used in professional rodeos today come from breeding programs where they are specifically bred to buck. These horses are conditioned to riding in specially modified double level trailers from a young age.

We must stand together and educate our representatives in Congress on the negative consequences of this legislation. Please start today by contacting your elected officials in Congress and urging them to oppose provisions in the Highway Bill that prohibit the transport of horses in double deck trailers.

Cattle Fax Update

On Wed., Jan. 11, the markets were relatively calm on the day. Live cattle futures closed mixed with the front contracts gaining on the back contracts. Feeder cattle futures closed about a quarter lower. The CME Feeder Index reported yesterday stands at \$148.91, up \$0.42 (all-time high). Boxed beef was over \$1 lower- the packer remains in the red. Lean hog futures fell over \$1/cwt. and values are testing lows from this summer and last month. Grain futures traded mixed to lower. Soybean futures fell about \$0.26/bu.
